A retired officer of the Commercial Tax Deptt of any State Govt or the Central Board of Excise and Customs, Deptt of Revenue, GOI, who during his service under the Govt had worked in a post not lower in rank than that of a Group A' Gazetted Officer for a period of not less than two years or Group 'B' Gazetted Officer for period of not less than five years.

#### (c) The consultant must possess:-

- (i) Interpretation skills of tax laws.
- (ii) Expert Knoweledge of the laws.
- (iii) Should have been updated with all latest circulars, notifications, rules & alike related to tax, as the tax laws keeps on changing & modifiedfrom time to time.
- (iv) Should have been authorized by the Central and/or State Govt for carrying out all tax related activities.

#### (d) Qualities and Role Expected from the consultant:-

(i) The consultant would be required to work out the financial implications of implementations of GST after 01 Jul 2017 in civil construction contract works visar-vis the tax structure prevalent prior to 01 Jul 2017, for the works carried out after 01 Jul 2017. As the works were carried out in different states, the professional should be capable of assessing the financial implication as per relevant tax structures of the concerned states.

- (d) Should have specialization to file claim for GST refund/ reimbursement.

- (a) The consultant must be qualified enough to handle the tax laws and GST requirement of HQ DG MAP and possess requisite autoorized certificate.
- (b) Should be available all the times throughout the contract period.
- (c) Must understand the reqmts & finacial goals of HQ DG MAP.
- (d) Must be proactive in comn with concerned Offr in HQ DG MAP.
- (e) Must have knowledge of CA. Convering aspects of corporate/non-corporate aspects.

#### **CONDITIONS OF HIRING**

- 3. Consolidated package of Rs. 1,00,000/- per month will be paid except for any absence other than the leave mentioned at Para 5 below. No other perks/benefits such as Gratuity, HRA, CCA, Transport Allowances, Medical Re-imbursement etc are admissible.
